Fee: \$750-includes stallion service fee plus a shipping fee of \$450 for each required shipment. Shipment will be FedEx Stand or Priority Overnight.

(\$300 due with contract, balance due prior to shipping)

The mare owner understands that he/she must comply with the following when dealing with shipped semen;

- Confirm orders for semen 72 hours prior to shipment by phone call to Ben Eike at 620-988-0020. Voice mail messages, Facebook messages, and texts not valid for shipment requests-you must speak to Ben.
- Cancellations must be made by 8:30am CST the day of shipment.
- Cancellations after 8:30am CST will be subject to a \$100.00 cancellation fee.

Additional cooled shipped semen shipments will be \$450 each paid prior to shipment. Venmo payments accepted, add 3%.

Mares on the premises of Bent E Quarter Horses have breeding priority on any given day, therefore, we make no guarantee cooled semen will be available for a specific day.

Bent E Quarter Horses is not responsible for untimely deliveries and/or condition of shipped semen, as we have no control of shipment after it leaves our custody. Bent E Quarter Horses only assumes responsibility to ship semen in viable condition, and shall not be held liable for contamination of semen during and after shipment, loss of viability, or any costs arising from shipments delayed, damaged or lost in transit.

Mare Owner agrees to use all cooled semen provided for the mare named in this Agreement and no other.

Bent E Quarter Horses agrees to ship cooled semen as described above. If the mare fails to settle for any reason the mare owner will not hold Bent E Quarter Horses, Ben Eike, or Craig Eike responsible or liable for damages to the semen, or condition of the Mare.

This contract contains a <u>conditional guarantee</u>. A live foal is defined as a new born foal which stands and nurses, and survives a minimum of 24 hours. <u>In order for a guarantee</u> to apply, the following conditions must be met:

- A.) Mare must be vet checked via ultrasound for pregnancy 14 -18 days following the last breeding date.
- B.) Mare must be kept in good physical condition throughout pregnancy, including Rhino EHV vaccinations at months 5, 7 & 9 of pregnancy.
- C.) Stallion manager/owner is to be notified within 10 days of discovery of an open mare, stillbirth, or the death of foal less than 24 hours old.

This contract and guarantee are non-transferable. In the event that a rebreed (return privilege) is granted, it will apply to the 2022 season only, with a prepaid chute fee of \$450 (includes 1st 2022 shipment sent via FedEx Overnight). Additional shipments at \$450 each, paid prior to shipping. (Venmo accepted, add 3%)
